

RULES FOR SUBMITTING SCIENTIFIC ABSTRACTS

1. Abstracts of original works will be accepted to be sent during the VIII NEUROLATINVET Congress. These include research works, prospective or retrospective studies, case series and interesting clinical cases, which should expose topics of veterinary neurology, in its various subareas. As they are original works, those that have been previously presented or published will not be accepted.
2. All submitted abstracts will be evaluated by a Scientific Committee which will decide whether to accept them or not and may indicate corrections prior to their final acceptance. In all cases, the author will be notified of the acceptance or rejection, within 3 weeks of receipt. Accepted abstracts will be published in the annals of the VIII NEUROLATINVET Congress, as a digital supplement in the *Revista Argentina de Neurología Veterinaria* (<https://neurovetargentina.com.ar/revista.php>).
3. Scientific Committee will select the most interesting abstracts to be presented orally, during the event in a virtual room. Finally, three of the best ones will be selected, and the authors will be distinguished with a certificate and a registration for the next congress. The corresponding authors chosen for oral presentation will be communicated via email by the Scientific Committee with all the pertinent details.
4. All abstracts must be written in original language (English, Portuguese, etc.) **AND** in Spanish and sent to the Scientific Committee of the VIII NEUROLATINVET Congress, as attachment file, to the email cientifico@neurolatinvet.net, until August 31, 2021.
5. Each abstract must have a maximum of 6 authors. The corresponding author must necessarily be previously registered in the congress and can submit up to 2 papers. There is no limit of papers for non-corresponding authors. The corresponding author will be in charge of the oral presentation in case your abstract is one of the selected.
6. In the "subject" of the email, you must place: "VIII NEUROLATINVET Congress - corresponding author's last name"; In the body of the message every abstract must include: 1) Title of the work; 2) Authors; 3) Corresponding author with his last name, first name and email. The corresponding author must attach the event's registration proof.
7. The abstract must be written in Word format, under the following rules: The title will be written centered, in bold and UPPER CASE, with 11-point Arial font. In the next line, the authors' last names and initials will be entered, without academic degrees or titles (eg, Rodríguez MN, López RS & Méndez AF), with 11-point Arial font, centered. The corresponding author's name must be underlined. In the next line, in 10-point Arial font, centered, the corresponding author's work institution, city/state/country and email address will be entered.

8. The body of the abstract will be written with 10-point Arial font, single-spaced, without indentations, without underlines and justified, beginning each section in a new paragraph. Scientific names and Latin text must be italicized. In no case should it exceed 1 (one) page in length (type A4), with all margins at 2cm.
9. Research papers should include the following sections: 1. Introduction (including study objectives). 2. Materials and methods, including the statistical method used. 3. Results. 4. Discussion and / or Conclusions. 5. References (no more than 3).
10. The clinical cases must consist of: 1. Introduction. 2. Review of the animal case (s). 3. Clinical examination and complementary methods carried out. 4. Results. 5. Discussion and / or Conclusions. 6. References (no more than 3).
11. See the available example of a formatted abstract in the rules. Abstracts that don't meet the aforementioned criteria will be rejected, without going to the Scientific Committee.
12. The fact of submitting an abstract implies acceptance of these rules. Since abstracts will only be received via email and, consequently, the authors that appear in each abstract will not have to send a printed and signed copy, the corresponding author of each abstract will be responsible for having the approval of each author, to present the work at the VIII NEUROLATINVET Congress. Any claim from the rest of the authors related to the presentation of the abstract will be the exclusive responsibility of the corresponding author. Those who submit a paper to the VIII NEUROLATINVET Congress will receive an email confirming receipt and after the evaluation an email of acceptance or rejection of it.
